- to promote the research and participate in studies on China in a variety of fields, with a focus on Chinese Law, Governance and Civilization, especially with regard to relation to Europe.
- to raise the consciousness of understanding and knowledge between Europeans and Chinese
- to help establish the framework for historical and cultural respect
- to encourage the promotion of Sino-European Academic Staff and student exchanges as well as research on China
- to plan training sessions, workshops and seminars on European Law and Governance for Chinese students as well as Chinese Law and Governance for European students
- to create a Chinese Studies research network among EPLO members

Functioning as an autonomous unit within the EPLO, the Institute is overseen by its Director and a dedicated Scientific Council. This Council is constituted by fifteen internationally acclaimed specialists, representing a broad spectrum of European and Chinese scholarship.
